The Heritage Park Entertainment Centre wishes to ensure that your function is a complete success, therefore certain terms and conditions have been established, so both parties are fully aware of obligations.

We, HP Entertainment Centre, grant you, the Client Company set out in the Event Booking Contract, permission to use the Fun Spaceship/Function Hall at the Host Venue during the Event Times on the Event Date subject to the following terms and conditions:

The Booking Contract between you, the Client and us Heritage Park Entertainment Centre, shall comprise the completed Booking Form and these Terms and Conditions. All bookings are subject to these Terms and Conditions to the exclusion of all others.

Guaranteed Numbers – Final numbers are required one (1) week prior to the event.

Prices – will be confirmed in writing along with the final function details and are valid for 7 days from the date of this contract. Every endeavour is made to maintain prices as printed, but these may be subject to change without notice.

Venue/Space Hire – is subject to period required, number of guests in attendance and overall catering requirements. This charge can be discussed with our Events team when enquiring about your function.

Displays and Signage – No items are to be attached, pinned, nailed, screwed, stapled or glued to the walls, doors or other surfaces of any area in the Centre.

Smoke Free – Under QLD Legislation, the Entertainment Centre is a non-smoking venue.

Food & Beverage Catering – Clients are not permitted to supply their own food. Under no circumstances will the HP Entertainment Centre allow any function to bring any food without prior permission from the General Manager/Executive Director.

Any reduction in attendance numbers subsequent to notification of final numbers will be subject to charging the full contract amount. No food or beverage items are permitted to be taken off the premises without prior approval.

Menu Variations - It may be necessary due to availability of supplies to make substitutes to the selected menu. Any changes in menu selection or pricing will be notified to the organiser and subsequent substitutions can be arranged.

In addition, menu and beverage listings are subject to price alteration in accordance with seasonal market variations.

Compliance – Clients will be responsible to ensure the orderly behaviour of their guests and the HP Entertainment Centre, reserves the right to intervene where it sees fit.

Noise Restrictions – Noise emanating from the premises including amplified or non-amplified noise and patron noise must not exceed 75dBI, fast response, when measured approximately 3 metres from the primary source of the noise. Conversation level must also be acceptable. Live Entertainment is at the discretion of Management of the HP Entertainment Centre. If noise exceeds the acceptable limit, Management reserves the right to cease the entertainment.

Loss & Damages – On signing this agreement, you agree that you are liable for ANY damage or loss of equipment provided at the HP Entertainment Centre. This includes (and is not limited to) Audio Equipment, walls and seating in its entirety.

DEPOSIT & PAYMENT

A deposit of \$200 is required to guarantee the Entertainment space.

A Booking is only confirmed once we issue a Booking Confirmation following receipt of the agreed Deposit, a completed Booking Form, completed Risk Assessment (if required) and a signed copy of these Terms & Conditions. Until this time your booking is provisional and we may cancel it, without liability, by sending you written notice of cancellation. If Police and Licensing respond to the Risk Assessment submitted in connection with the Event with anything other than low risk, we reserve the right to cancel the Event immediately without liability and the Deposit will be refunded to you.

Function Cancellations - Cancellations and/or event changes must be advised in writing. Cancellations after written confirmation and deposit have been received will be subject to the following cancellation fee and charges:

- **Notice within 7 days prior to the Event** - 100% of the agreed contract amount will be charged as a cancellation fee.
- **Notice within 14 days prior to the Event** - 50% of the agreed contract amount will be charged as a cancellation fee.

If the function space is able to be re-sold, the deposit will be transferred to another function date and must be used within 3 months.

Final Details – (menus, beverage requirements, entertainment, audio-visual requirements, room set-ups, start and finish times) must be confirmed no later than 5 business days prior to the commencement of the function.

These Terms and Conditions shall be governed by, and construed in all respects in accordance with, English law.

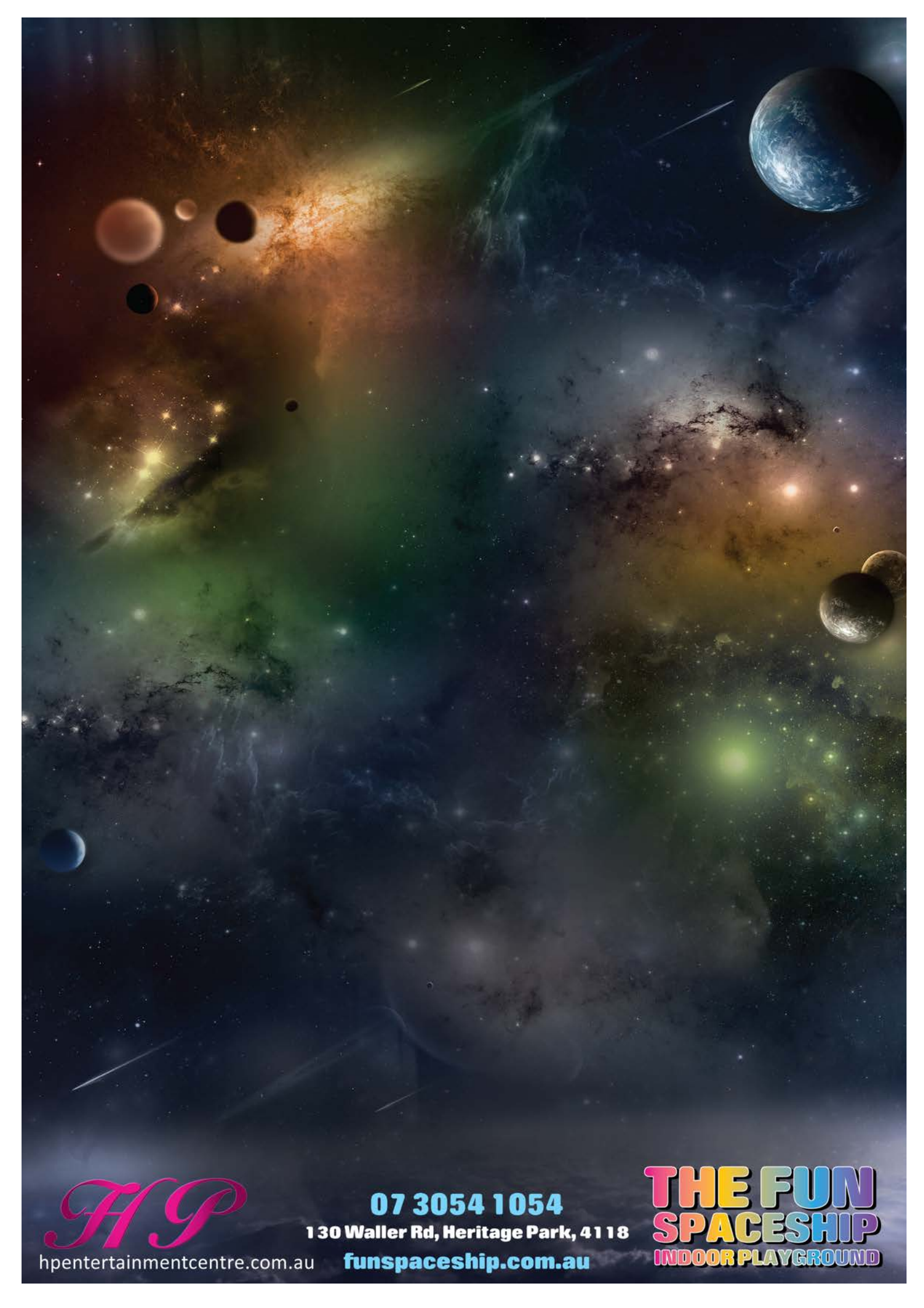
